ORDINANCE NO. 83-29

AN ORDINANCE AMENDING THE OKALOOSA ISLAND FIRE DISTRICT ORDINANCE; EXPANDING THE PURPOSE OF THE DISTRICT TO INCLUDE OTHER RELATED SERVICES (TO EXCLUDE AMBULANCE SERVICES) AS OUTLINED BY THE NATIONAL FIRE CODES; PROVIDING AN EFFECTIVE DATE AND REPEALING ALL ORDINANCES OR PROVISIONS THEREOF IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF OKALOOSA COUNTY, FLORIDA:

SECTION 1. Subsection 1 of Section 1 of Ordinance No. 77-4
is hereby amended to read as follows:

## "Section 1: Creation; Boundaries.

(1) Upon this Ordinance becoming a law all of the following area in Okaloosa County shall be established as a special fire protection district which is created for the purpose of providing fire protection and related services (to exclude ambulance services) as outlined by the National Fire Codes for the benefit of the residents within said district, to be known as the Okaloosa Island Fire District in which it may sue and be sued, lease, own, possess, and convey real and personal property, by purchase or gift, or otherwise, in order to carry out the purposes of this Ordinance:

## AREA:

The area includes all of Santa Rosa Island Subdivision as recorded in Plat Books 2 and 3..., Public Records of Okaloosa County, Florida."

SECTION 2. This Ordinance shall take effect upon receipt of official acknowledgment from the Department of the State of Florida that it has been filed, and does hereby repeal all ordinances or provisions thereof in conflict herewith.
