- I. <u>MEETING:</u> Meeting was called to Order @5:30 P.M. by Chairman Jones.
- II. <u>ROLL CALL</u>: All Fire Commissioners were present. Also present were Chief Carvalho and Assistant Chief Strawn.
- III. <u>APPROVAL OF OCTOBER AGENDA</u>: Commissioner Jones called for an approval of the Agenda. **Commissioner Mitchell** made a motion to approve the Agenda, **Commissioner Simpson** seconded, all were in favor, none opposed, motion carried.

#### IV. PUBLIC COMMENTS: None

- V. <u>APPROVAL OF THE MINUTES</u>: The minutes for the OCTOBER 18, 2017 regular meeting were reviewed. Commissioner Jones called for corrections, deletions, and/or additions. Commissioner Edlund pointed out that he attended the previous meeting which the minutes do not show, Commissioner Mitchell made a motion to accept the Minutes with the change as described. Commissioner Simpson seconded the motion, all were in favor, none opposed, motion carried.

#### VIII. <u>OLD BUSINESS</u>:

- A. BEACH TRUCK: The purchase of the new admin vehicle (State Bid) which will be utilized as the secondary/backup beach truck and as the shared Fire Chief and Inspector vehicle was discussed. We are completing the process and the issue of an aluminum body on the truck was discussed. This will be further investigated as whether this will cause too much corrosion to be a viable option. We will discuss further with the fleet manager and address the board at the next meeting.
- B. BANK/FINANCIAL UPDATES: The banking changeover removing Chief Tilley as an account user and adding Assistant Chief Strawn has been completed. Additionally, Eglin Federal Credit Union (EFCU) has been requested to allow OIFD personnel the opportunity to personally bank with them as part of their Special Employee Group program. Chief Carvalho submitted on letterhead a request for OIFD upon approval, to be accepted as an employer organization.
- C. NEW FIREFIGHTER- ZANDER ANGELOVIC: OIFD would like to welcome our newest member. Zander will be at the Christmas Party and will be introduced to the Fire Board there.

### IX. <u>NEW BUSINESS:</u>

A. BLUE EXPEDITION: Chief Carvalho stated to the Fire Board that the Blue Expedition is officially dead. The truck had been running rough and hot for a while and when serviced the mechanic at L&L stated the engine block was cracked and the head gasket was blown. The cost to repair was impractical. Chief Carvalho asked that the truck be decommissioned and be utilized as a training vehicle. **Commissioner Mitchell** made a motion that the vehicle

- be decommissioned and then used as a training aid and that additionally we attempt to sell the wheels or keep them for use on another vehicle. **Commissioner Linz** seconded the motion, all in favor, none opposed. Motion carried. Chief Carvalho stated that he would contact the Fire Board when it came time to train so that they could watch some of the training activities.
- B. CONTRACTUAL SAVINGS: Chief Carvalho presented to the board the savings to the district from the previous *Fire Chief Employment Agreement* to the current agreement. Attorney Jeff McGinnis worked on the agreement and had asked for these savings to be addressed to the board.
- C. BEACH REPORT EMAIL: Chief Carvalho read 2 e-mails into the minutes related to beach runs and a Halloween event that we attended. Both e-mails were positive and thanking us for our service and participation.
- D. THEFT OF PROPERTY: Chief Carvalho discussed a burglary by smash-and-grab that took place at the Destin Dog Park whereas his personal vehicle (and 3 others) were broken into by smashing the windows and grabbing his briefcase type bag that contained his OIFD pager and SLERS radio. Chief Carvalho stated that several days later a woman attempted to fraudulently cash one of his voided checks and was apprehended after a high-speed chase from Gulf Breeze to Destin. A police report was generated and the OIFD property items were included in the original report. No information on the stolen items have been related as of yet, however the OCSO Deputy stated that they believe the suspect has been apprehended.
- E. SHOP WITH A FIREFIGHTER/BIKES OR BUST: Daniel Blair LOCAL 2617 President gave a briefing on this year's charity events and those wishing to give can do so by providing the donation to the union and they would assist purchasing the items.
